Interlocal Agreements and Bid Piggybacking

Stacia Hollar has asked that I respond to your request for reconsideration and clarification of earlier advice we provided regarding the following question:

Does a local government have authority to utilize the bid proposal received by another local government entity without first entering into an interlocal agreement with that entity?

Our current interpretation of the law is that, although such an agreement may be a good business practice to ensure compliance with particular bid law requirements, it is not legally necessary to have entered an interlocal agreement <u>prior</u> to utilizing another entity's contract.

ANALYSIS

Initially, it should be noted that there is a diversity of opinion on this issue in the local government legal community. We believe the following general principles should be kept in mind when addressing this issue: (1) many local governments may exercise those powers either expressly granted or necessarily implied from express grants of authority; (2) code cities and charter counties may generally exercise any powers capable of exercise by such an entity unless otherwise limited by law; and (3) there is a strong public policy in this state favoring application and enforcement of competitive bidding laws.

Local government competitive bidding statutes are found throughout the Revised Code of Washington in those chapters relating to different types of local government entities. The specific requirements for conducting bidding vary by entity, necessitating reference to each particular entity's specific bidding requirements to determine what (if any) statutory bidding requirements exist. In our opinion, an entity making a purchase bears the burden of establishing that the purchase has been made in compliance with bidding requirements.

Purchases may be made pursuant to joint purchasing contracts or programs entered by two or more public agencies. Under ch. 39.34 RCW, the Interlocal Cooperation Act, two or more public agencies are authorized to exercise their powers jointly. RCW 39.34.030(1); 39.34.080. However, each participating agency must have the power to do individually what it agrees to do jointly. This Office has consistently advised that ch. 39.34 RCW permits public agencies to enter into interlocal agreements to do jointly only what each agency could do independently. The statute does not broaden the powers of public agencies or relieve them of their statutory obligations. See AGO 1991 No. 19 at 6-7; AGO 1988 No. 19 at 5; AGO 1979 No.

We did miss you at the Pack Forest. It was a good meeting. I brought up the KCDA issue the end during the "other topics of interest" time. The talk around the table was that AAG's have different interpretations of the law, and that results in what amounts to a double standard. Seems odd to me, but here's what Yvonne reported to me:

WSU has an Intergovernmental Cooperative Purchasing Agreement with KCDA, signed in 2002. We utilize only the <u>copier contract</u>. All of the state contract copier vendors we use have KCDA pricing. It is often better than state contract pricing. Each of these vendors gives WSU the best pricing available, between the two contracts. This has saved WSU thousands of dollars. We negotiated waiver of the KCDA contract usage fee. The vendors absorb this cost.

I don't know if anyone performed Jack Ziegler's 8-question test on the KCDA copier bid, but Yvonne informed me that Rod Ramer, Purchasing Manager for Community Colleges of Spokane, has hard copy of bid documents.



We interpret the Interlocal Cooperation Act as authorizing public agencies to contract with each other in advance to conduct a joint purchasing program that complies with all bid requirements of each public agency involved. Therefore, if public agencies agree in advance to conduct a joint purchasing program, it should be done pursuant to interlocal agreement.

However, we do not interpret the Act as mandating a rule that purchases can only be made from another public agency's purchase contract pursuant to such an interlocal agreement. Rather, our interpretation of general local government bidding requirements is that public agencies may subsequently avail themselves of purchase contracts entered by other public agencies if (1) the contract is determined to have been awarded in compliance with all bidding requirements of the agency seeking to purchase, (2) the contract was awarded with terms indicating that it would be available for use by other public entities, and (3) there is no statutory provision prohibiting such a purchase.
